CREDIT TERMS I CREDIT AGREEMENT:

By signing below, the Purchaser/Customer agrees to the following credit terms:

Note: This application for Business Credit is to be used in connection with commercial or business purposes only and not for the purchase of personal, family, or household goods or services. You agree and represent and warrant at the time of each purchase, that this Account shall be used only for purchases for commercial or business purposes, and not for personal, family, or household purposes, and you understand that COMPANY is relying upon this representation in entering into this Agreement. In this connection, you understand that your agreement not to use this Account for personal, family or household purposes means that important duties imposed upon us, and important rights conferred upon a consumer, pursuant to certain federal or state laws, will not apply to this Account.

1. IF SALES ARE TAX EXEMPT, PLEASE ATTACH CERTIFICATE (TC-721). By state law, CMC Rock, LLC, (hereinafter "CMC") will bill for sales tax until an exemption certificate is received.

2. Maximum credit limit is determined by CMC's credit departments.

3. Payment in full of all invoices is due and payable on the date specified on each invoice and payment must be sent directly to CMC.

Balances not paid in full when due will incur FINANCE CHARGES at the rate of 1 1/2% per month, which is 18% ANNUAL Λ **PERCENTAGE RATE**, from the date of the invoice until paid in full.

If the Purchaser/Customer defaults under the terms hereof, Purchaser/Customer agrees to pay all of CMC's costs of collection, Including all litigation costs and attorney fees, whether or not suit is actually filed.

6. Mechanic's Lien filing fee is \$200.00 for each separate lien filed and will be charged to and paid by Purchaser/Customer as a cost of collection.

NOTICE TO UTAH RESIDENTIAL PROPERTY OWNERS. In accordance with UCA 38-11-1 07-8, notice is hereby provided that under Utah law an "owner" of residential property may be protected against mechanic's liens on an "owner occupied residence" and from other Utan law an "owner" of residential property may be protected against mechanic's liens on an "owner occupied residence" and from other civil action being maintained to recover monies owed for "qualified services" performed or provided by suppliers and subcontractors as a part of this contract if either section (1) or (2) are met. Section (1): (a) The owner entered Into a written contract with either an "original contractor" who is property licensed or exempted from licensure, or with a "real estate developer"; and (b) The owner must pay in full the original contractor or real estate developer or their successors or assigns in accordance with the written contract and any written or oral amendments to the contract. Section (2), the amount of the contract with the general contractor totals\$5,000 or less. An owner who can establish compliance with either section (1) or (2) may apply for a certificate of compliance with the Utah Div. of Occupational & Professional Licensing. The application is available at www.dopl.utah.gov/rlrf.

8. Electronic Communication: In accordance with UCA 46-4, Utah Uniform Electronics Act, by signing below the Purchaser/Customer agrees to receive electronically all accounting and billing records. No paper copies of truck tickets, invoices, or statements will be provided. All such records will be emailed to the address provided for "Billing Contact" above. It is the Purchaser/Customer's responsibility t o keep this email address accurate and updated. The Purchaser/Customer has 10 business days from receipt of invoice to dispute any billing information. The Purchaser/Customer will be billed every two weeks via email. CMC may also record video and/or take photographs of all trucks being weighed on the scale as backup documentation for CMC's records.

The above information is submitted for the purpose of obtaining credit and is warranted to be true. I hereby authorize and consent to allow CMC and its authorized agents to investigate my personal and my company's credit and financial responsibility, including seeking information from credit bureaus, banks and others.
